No Public comment.

The meeting was called to order at 8:05 a.m. Ms. Wiesneski made a motion to approve the minutes of the previous meeting; seconded by Mr. Koblitz. The motion carried.

Motion by Ms. Wiesneski to convene in closed pursuant to Wis. Statutes Section 19.85(i)(e) for consideration of personal financial data related to the application File#17001; seconded by Mr. Rekau the motion carried 6-0 on roll vote.

Discussion was held in closed session.
